Note on the organization of the document

1. This document provides an overview of requests from bilateral agencies, and whether these are eligible for approval by the Executive Committee in light of the maximum level of bilateral cooperation available for 2013. It cross-references relevant meeting documents that include a discussion on the bilateral requests, and contains the standard recommendation on the year of assignment for bilateral cooperation.

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

Introduction

2. A total of six projects for bilateral cooperation with a value of US \$2,300,536 (including agency fees) has been submitted to the 71st meeting as shown in Table 1.

3. Table 2 provides a summary of the request for bilateral co-operation from the Government of France. The value of this request (US \$282,500), does not exceed the 20 per cent of France's 2013 bilateral contribution of (US \$2,082,959).

Request from the Government of Germany

Table 3 provides a summary of the requests for bilateral co-operation from the Government of Germany. At the 70th meeting Germany's approval exceeded Germany's 2013 bilateral allocation by US \$180,267¹. The value of Germany's request (US \$1,927,636), combined with the amount of US \$180,267 approved at the 70th meeting, does not exceed the 20 per cent of Germany's 2014 bilateral contribution (US \$8,182,837) as 2012 and 2013 allocation is fully utilized. There is no issue as Germany's request remains within Germany's 20 per cent allocation for the triennium.
