# 2011-2014 BUSINESS PLANS AND ANNUAL TRANCHE SUBMISSION DELAYS

This addendum is provided to update the recommended/reviewed funding values compared to the values in the business plans following the completion of project review and the associated draft agreements for the HCFC phase-out management plans (HPMPs).

• **Replace** Table 3 **and** paragraph 9 **with** the following:

Projects submitted after review to the 64<sup>th</sup> meeting include project values amounting to US \$173,184,352 (including US \$1,433,792 that were not in the business plans), which exceed the amount included for them in the 2011 business plans by US \$26.9 million. Of this amount, US \$24 million is for activities requested for China; US \$1.8 million for Mexico; and US \$1.4 million for Lebanon. Activities not included in the business plans cover HCFC activities for 9 projects (US \$1,433,792) including preparation in the foam sector for Argentina by the World Bank; HPMPs in

low-volume-consuming (LVC) countries (Central African Republic (the), Saint Kitts and Nevis, Saint Lucia and Saint Vincent and the Grenadines) where the business plans had only listed UNEP as an implementing agency and UNDP and UNIDO are now addressing the investment components; HPMPs in LVC countries (El Salvador and Jamaica) where the business plans had only listed UNDP as an implementing agency and UNEP is now addressing the non-investment components; an HPMP in the refrigeration air-conditioning manufacturing sector plan for Cameroon by UNIDO; and an HPMP in the refrigeration servicing sector for China by Japan.

• **Replace** paragraph 10 **and** Table 4 **with** the following:

10. Table 4 presents, by agency, the value of accounts included in the 2011 business plans and the balance of funds from projects in the 2011 business plans, which have not been submitted. Table 4 is updated based on the Secretariat's recommendations to the  $64^{th}$  Meeting.

13. Projects submitted after review to the  $64^{th}$  meeting include project values amounting to US \$672,352,495 which exceed the amount included for them in the 2011-2014 business plans by US \$94.4 million.

• Add paragraphs 14 (bis) and 14 (ter) and Table 7 under the section on Forward commitments as follows:

14 (bis). Forward commitments *inter alia* consist of funding for multi-year agreements (MYAs) and "other standard activities" such as institutional strengthening, budget of the Fund Secretariat, Treasurer and Executive Committee meeting costs, UNEP's Compliance Assistance Programme (CAP), and the core unit costs for UNDP, UNIDO and the World Bank. Funding for "other standard activities" is based on 2011-2014 business plans taking into consideration the decisions from the 63<sup>rd</sup> meeting of the Executive Committee.

14 (ter). Table 7 presents the total amount of forward commitments assuming that the requests submitted to the  $64^{th}$  Meeting are approved at the levels contained in the submissions following review by the Secretariat. If the requests are approved at the levels as recommended after review to the  $64^{th}$  Meeting, an additional US \$67.8 million would be needed to cover forward commitments. The total amount of existing commitments for the period 2011 to 2031 is US \$263.1 million.
