REQUESTS FOR BILATERAL CONTRIBUTIONS

An additional request for bilateral assistance was received from the Government of France in cooperation with UNEP/IEPAC (Annex 1). The Government of France is requesting to credit US \$30,000 in bilateral assistance against its 1994 contribution to the Fund for the preparation of the Vietnam country programme. This request conforms to the criteria and guidelines of the Committee and the total requests for offsets to the contribution of the Republic of France at this meeting do not exceed 20 per cent of the French contribution to the Fund for the year 1994. Consequently, the UNEP/IEPAC budget for the preparation of the Vietnam country programme is reduced from US \$60,000 to US \$30,000.
