3. Las solicitudes para la preparación de: las etapas II, III o IV de los planes de gestión para la eliminación de HCFC (PGEH), los planes de aplicación de la Enmienda de Kigali relativa a los HFC (PAK) y/o actividades relacionadas con inversiones, y los inventarios nacionales de bancos de sustancias controladas de desecho de conformidad conforme a lo dispuesto en la decisión 91/66, así como las solicitudes para la renovación de los proyectos de fortalecimiento institucional, se presentan en las enmiendas a los programas de trabajo de 2024 del PNUD², el PNUMA³, la ONUDI⁴ y el Banco Mundial⁵ y en el documento sobre cooperación bilateral⁶.
