لأسباب اقتصادية، لقد تمت طباعة هذه الوثيقة بعدد محدود، فيرجى من المندوبين أن يأخذوا نسختهم معهم الى الاجتماع وألا يطلبوا نسخا اضافية.

* استبدال الفقرة 4 بالفقرة التالية:

4 يظهر رصيد المبالغ من المشروعات المحولة كرقم سالب لأنه يتألف من مساهمة ثنائية سجلت كمدفوعات من كندا. وبمجرد الموافقة على التحويل، سيحذف أمين الخزانة هذه المبالغ من المساهمات الثنائية، مما يخفض بالتالي مبلغ المساهمات الكلية. وينبغي على أمين الخزانة أن يحول أيضا مبلغ 238 650 دولار أمريكي إلى منظمة الأمم المتحدة للتنمية الصناعية لخطه القضاء التدريجي لصربيا حسب المقرر 10/50 وكذلك مبلغ 918 254 دولار أمريكي حسب المقرر 44/50. وينبغي ملاحظة أن السويد أعادت رسيدا قدره 250 860 دولار أمريكي من مشروعها للتعاون الثنائي الذي جرى تحويله إلى منظمة الأمم المتحدة للتنمية الصناعية. ويبين التأثير الصافي للجدول 1 على مستوى المبالغ المتاحة المشار إليه قبل المقرر بشأن التحويل في حالة المساهمات (UNEP/OzL.Pro/ExCom/51/3) إلى رقم سالب مقداره 509 364 دولار أمريكي.

* اصف الفقرة 15 (مكرر ثالثا) كما يلي:

تقرير منظمة الأمم المتحدة للتنمية الصناعية عملا بالمقرر 44/50

15 (مكرر) نظرت اللجنة في اجتماعها الثامن والأربعين في تقرير بشأن تطبيق دخل متنوع في التقارير المرحلية للوكالات بدلا من تعيين جميع التكاليف إما للمشروعات أو للتكاليف الإدارية. وأكدت اللجنة أن التكاليف الموافق عليها للوكالات المنفذة ينبغي تصنيفها إما تكاليف للمشروعات أو تكاليف إدارية (المقرر 38/48 (ب)). وعند تسوية الحسابات في اجتماعها الخمسين، لاحظت اللجنة التنفيذية أن منظمة الأمم المتحدة للتنمية الصناعية قد كتبت لتؤكد أنها ستمثل بالمقرر 38/48 (ب) من خلال تعيين الرسوم المتنوعة البالغة 361 966 دولار أمريكي للفترة حتى كانون الأول/ديسمبر 2005 إما إلى تكاليف المشروعات أو التكاليف الإدارية. ولاحظت أيضا أن منظمة الأمم المتحدة للتنمية الصناعية قد اقترحت استيعاب مبلغ 107 048 دولار أمريكي مقابل التكاليف الإدارية للمنظمة وعينت مبلغ 254 918 دولار أمريكي لتكاليف المشروعات. وبالتالي تكون المسؤولية المشتركة لمنظمة الأمم المتحدة للتنمية الصناعية هي مبلغ 107 048 دولار أمريكي. وطلبت اللجنة من المنظمة أن تقدم تقريرا عن الأرصدة إلى الاجتماع الحادي والخمسين للجنة التنفيذية، وقائمة بالمشروعات التي تصل رسومها 254 918 دولار أمريكي المقترح أن تسجل في ذلك الاجتماع (المقرر 44/50 (ه)).

15 (مكرر ثالثا) قدمت منظمة الأمم المتحدة للتنمية الصناعية قائمة بالمشروعات لتخصيص الرسوم المتنوعة عملا بالمقرر 44/50 المرفق باعتباره المرفق الثاني بهذه الوثيقة. وتجرى إعادة المبالغ مقابل حسابات المشروعات حيث توجد أرصدة صافية قد تمت إعادتها فعلا إلى اجتماعات سابقة للجنة التنفيذية. ولن ينتج عن إعادة المبالغ أي تجاوزات في الانفاق على المشروعات. وقد ترغب اللجنة التنفيذية أن تحاط علما بأن منظمة الأمم المتحدة للتنمية الصناعية قد أعادت مبلغ 254 918 دولار أمريكي للمشروعات كما يدل على ذلك المرفق الثاني.

مجموع الموارد المتاحة للاجتماع الحادي والخمسين

16 تشير حالة المساهمات والمدفوعات في 16 آذار/مارس 2007، إلى أن أمين خزانة الصندوق كان لديه أرصدة متاحة تبلغ قيمتها 57 516 295 دولار أمريكي في شكل نقدي وسندات إذنية. وبعد الأخذ في الاعتبار المبلغ السالب في الجدول 1 البالغ 509 364 دولار أمريكي زائدا تكاليف دعم الوكالة في الجدول 4 البالغة 24 678 دولار أمريكي، يبلغ المستوى الإجمالي للموارد المتاحة لكي توافق عليها اللجنة التنفيذية في اجتماعها الحادي والخمسين مبلغ 57 031 609 دولار أمريكي. ومع ذلك، تبلغ قيمة التقديمات إلى الاجتماع، باستثناء المسحوبات، 68 911 963 دولار أمريكي منها مبلغ 64 489 263 دولار أمريكي مطلوبا للاجتماع الحالي. ولهذا، وعلى

أساس القيمة الكلية للتقديمات التي تلقتها أمانة الصندوق، قد تكون هناك موارد غير كافية لتتمكن اللجنة التنفيذية من الموافقة على جميع المشروعات المقدمة في اجتماعها الحادي والخمسين

* **اضف** الفقرة 17 (مكرر) كما يلي:

17 (مكرر) نظرا للاختلاف في رسوم الوكالة للوكالة الثنائية ومنظمة الأمم المتحدة للتنمية الصناعية، سيتكلف الصندوق المتعدد الأطراف عند نقل خطة القضاء التدريجي لصربيا من السويد إلى منظمة الأمم المتحدة للتنمية الصناعية مبلغ 12 210 دولار أمريكي.

* **استبدل** التوصية 21 (و) بالتوصية: "تلاحظ أن مبلغ 57 031 609 دولار أمريكي (يحدث خلال الاجتماع) كان متاحا للجنة التنفيذية للموافقات في الاجتماع الحادي والخمسين؛"

* **اضف** التوصية 21 (ح) كما يلي: "تلاحظ إعادة مبلغ 254 918 دولار أمريكي إلى منظمة الأمم المتحدة للتنمية الصناعية للمشروعات المشار إليها في المرفق الثاني؛"
